# Appendix 5: Selected Worldwide Expatriate Killings and Attempted Killings, 1978-2011

“Appendix 5: Selected Worldwide Expatriate Killings and Attempted Killings, 1978-2011” documents selected instances in which attempts (successful or otherwise) were made on the lives of expatriates for which some allegation was made that the target’s own state, at an official or quasi-official level, was responsible. The appendix documents thirty-eight events targeting fifty individuals.<sup>1</sup>

Table 5 below is color-coded. A green cell indicates that the information for that cell is complete. A yellow cell indicates that the information for the cell is incomplete. Sources are regarded as complete when at least two sources refer to the event.<sup>2</sup> The “Identity of Target” column is color-coded to indicate the state accused for the attempt. This color-coding is as follows:

Bulgaria
Spain
United Kingdom
Turkey
United States
Russia
Romania

Information on the thirty-eight events is recorded in Table 5, which is organized into nine columns:

- (1) Year:** The year during which an event took place.
- (2) Date:** The date on which an event took place, with the month listed first. When the exact date is unknown, “xx” is used. For example, if an event took place in January but the exact date is not known, the date is listed as “01/xx.” If only the year is known, the date is listed as “xx/xx.”
- (3) Dead?:** Indicates whether or not the target was killed.
- (4) Identity of Target:** The name of the target.
- (5) Target’s Affiliation:** A description of the target as given by the sources. In some cases, the reason for which an attempt was made on the target. In other cases, the target’s occupation.
- (6) Location:** The location in which the attempt was made.

**(7) Method:** The method employed in the attempt on the target.

**(8) Perpetrator(s):** Those involved in the attempt, whether those who carried it out or those who ordered it.

**(9) Sources:** References to the sources from which the information was drawn. The sources are listed alphabetically in the “Sources” list at the end of the appendix. Each source is assigned a number which corresponds to references to it in the table.

The table features numerical references to both sources (as mentioned above) and notes. References to sources appear in standard font. References to notes appear in superscript and brackets (e.g. journalist<sup>[5]</sup>). Notes are found directly after Table 5, and the sources list appears below the notes.
