I. Introduction

Abstract

In “Appendix 2,” we compile geographic data from “[Appendix 1](#).” In “Appendix 1,” we documented attempted killings which met the following criteria:

- (1) The attempt was made against one or more Iranians.
- (2) The attempt took place outside of Iran.
- (3) Some allegation was made that the state of Iran was at least partially responsible for the attempt.

In “Appendix 2,” we document locales, local in table 2.1 and by state in table 2.2, in which the 77 events documented in “Appendix 1” took place.

Disclaimer

As we make clear in “Appendix 1,” we document events for which some *allegation* was made that the state of Iran was at least partially responsible for the attempt. It is not the case that Iranian responsibility has been reliably established for every event we document. Refer to “Appendix 1” for our sources.

II. Table 2.1

Key

Table 2.1 aggregates the number of events documented in “Appendix 1” by the location in which they occurred. To show trends, we have often approximated to the nearest metropolitan area, e.g. Washington, D.C. rather than Bethesda, Maryland. The first column lists the **location**. The second column lists the **number of** (relevant) **events** that occurred there.
